This agreement...

- 1. Is designed for 4-H members who were at least 8 years old by September 1 of the current 4-H year.
- 2. It is intended to assist youth whose academic/extra-curricular schedules or other special circumstances prevent them from participating fully in club activities and meetings.
- 3. For 4-H'ers continuing membership from the previous year, this contract must be established and on file in the Extension office by **January 15** of the current 4-H year.
- 4. For new 4-H enrollees, this contract must be established and on file in the Extension office by April 15 of the current 4-H year.
- 5. Will end on or before July 1 of the current 4-H year.
- 6. Should represent a compromise between leaders and members in terms of what members will need to do at the club and/or county levels to receive credit as "finishing" club members during the current 4-H year. (September 1 July 1)
- 7. Should include the terms and consequences that reflect the unique needs of the member and club.
- 8. Must be approved by the Extension office. Completed agreements should be sent to the office as soon as they are drawn up and approved by the member and leaders named. One copy will be kept on file at the Extension office. One copy will be sent to the leadership team.
- 9. Agreements not on file in the Extension office will be null and void.
- 10. Ending reports will be submitted by leaders on the Fair Ineligibility & Contract Report and turned into the Extension Office.
